

## LBNCo WA Price Disruption Promotion – Terms and Conditions

### FuzeNet’s LBNCo WA price disruption promotion – Terms and Conditions

The following terms and conditions apply if you undertake FuzeNet’s LBNCo WA price disruption promotion:

- 1. FuzeNet’s LBNCo WA Price Disruption Promotion offers the following:** – any new customer of FuzeNet, who signs up for a FuzeNet LBNCo service for at least 12 or 18 months, and who enters a valid promotional code and who remains an LBNCo service customer of FuzeNet for a subsequent period - then the customer will receive the following monthly pricing on the below plans:

The 25 - \$ 49.95 per month

The 50 - \$59.95 per month

The 100 - \$69.95 per month

New customers will also receive a free Huawei Router (value \$119.95), any activation fee will be waived (value \$49), if the New Development Fee is applicable, this will also be waived (value \$300).

- 2. Terms and Conditions of FuzeNet’s LBNCo WA Price Disruption Promotion** –By participating in FuzeNet’s LBNCo WA Price Disruption Promotion:

- a. you agree to be bound by FuzeNet’s usual Terms and Conditions of Use, and
- b. you also agree to be bound by the following Terms and Conditions of FuzeNet’s LBNCo WA Price Disruption Promotion.

- 3. Who can apply for FuzeNet’s LBNCo WA Price Disruption Promotion – LBNCo WA Price Disruption Promotion** is open to be accepted if you:

- a. are aged 16 years or over and have a current Australian residential address; and
- b. are not an existing customer of FuzeNet and you become a new existing customer of FuzeNet, or if you are an existing customer of FuzeNet and you re-sign for a further contract beyond the conclusion of your present contract; and
- c. sign up for a FuzeNet LBNCo service for at least 12 or 18 months; and
- d. on sign up you enter a valid unique Promotion Code when you sign up.

- 4. What internet services are available on FuzeNet’s LBNCo WA Price Disruption Promotion –** LBNCo WA Price Disruption Promotion applies to FuzeNet’s plans for LBNCo residential and business internet services in Western Australia, but only to plans of at least 12 – 18 months. FuzeNet’s LBNCo WA Price Disruption Promotion does not apply to FuzeNet’s other residential or business plans, or to FuzeNet’s premiums services. Any upgrades are additional to normal services and charges will be incurred for each upgrade.
- 5. How long does FuzeNet’s LBNCo WA Price Disruption Promotion last –** FuzeNet’s LBNCo WA Price Disruption Promotion is open to be accepted until 11pm on 31 December 2019 or, if FuzeNet publishes notice on the FuzeNet website at [FuzeNet.com.au](http://FuzeNet.com.au) to the effect that FuzeNet’s LBNCo WA Price Disruption Promotion remains open until another time, then until that time.
- 6. What is on offer with FuzeNet’s LBNCo WA Price Disruption Promotion –** Under FuzeNet’s LBNCo WA Price Disruption Promotion each qualifying customer will be entitled to:

  - a. The 100 plan (100/40Mbps) Internet service at the discounted rate \$69.95 per month for the life of the contract (12 or 18 months) or; The 50 plan (50/20Mbps) Internet service at the discounted rate \$59.95 per month for the life of the contract (12 or 18 months) or; The 25 plan (25/5Mbps) Internet service at the discounted rate \$49.95 per month for the life of the contract (12 or 18 months) and;
  - b. A free Huawei Router (value \$119.95);
  - c. Any activation fee will be waived (value \$49),
  - d. If the New Development Fee is applicable, this will also be waived (value \$300).
- 7. Terms may change –** FuzeNet may change these Terms FuzeNet’s LBNCo WA Price Disruption Promotion at any time. Changes to the Terms of FuzeNet’s LBNCo WA Price Disruption Promotion will be announced and current versions of FuzeNet’s Terms and Conditions of Use will be available at any time on FuzeNet’s web page.
- 8. Services may change or end–** FuzeNet may make modifications to the internet services it provides during FuzeNet’s LBNCo WA Price Disruption Promotion. FuzeNet may terminate the FuzeNet’s LBNCo WA Price Disruption Promotion at any time without reason or without notice.

- 9. As many as you like people** – a customer may use FuzeNet’s LBNC0 WA Price Disruption Promotion for as many new and minimum contracted services LBNC0 services in WA many times as they like.
- 10. But only one promotion at a time people** – a customer may participate in FuzeNet’s LBNC0 WA Price Disruption Promotion as many times as they like, but a customer may not FuzeNet’s LBNC0 WA Price Disruption Promotion together with any other promotion or incentive.
